9. <u>Update on Fritz Litigation</u> – (This item was called for review before Item 2.) Mr. Klausner joined the meeting via teleconference in order to discuss this item with the Board. He reminded the Board that the obligation to pay Mr. Fritz the court-ordered award is quickly approaching.
