<u>Attorney</u> – Attorney Greenwood advised the Board regarding a change in Delaware law extending certain liability protections for reckless conduct to corporate officers. In order to make the changes reflecting the law, companies would have to amend their charters which would require a vote of the shareholders.

Ms. Greenwood recommended adding language to the proxy voting portion of the investment policy making it clear that the Board does not support extending exculpation and immunity from personal financial liability to corporate officers and will vote against any proposed charter amendments seeking to provide such immunity. Motion was made by Jack McCluskey, seconded by Adam Feiner to accept the revisions to the proxy policy. The motion carried unanimously.
